In her new role, Kelli is committed to building upon the comprehensive strategic plan developed by her predecessor, Paul, and the Board of Governors. This plan focuses on five core pillars: Awareness, Advocacy, Science, Education, and Intellectual Property Protection, and not only represents FEMA's longstanding values, but the organization's renewed commitment to protecting and advancing the industry's interests.
